I would like to register my objection to the change of use of the Green Belt area around Horspath . The Green Belt separates Horspath from the industrial area of Cowley. I do not want the village of Horspath to be subjected to such a large housing development, which could lead the way to it becoming a suburb of Cowley.

Furthermore, I object that [REDACTED] I haven't been consulted on the plans before now.
