I thoroughly object to the use of the Green Belt area around Horspath. The Green Belt separates Horspath from the industrial area of Cowley. I do not want to live in a suburb of Cowley but in the village of Horspath.

I object that as a resident of Horspath I haven't been consulted on the plans before now.

Building a housing estate on the so called Northfield Estate would harm the rural environment and beautiful views from our village.

I do not believe that there are 'exceptional circumstances' that relate to SODC needing to build a housing estate on the Northfields Green Belt site.

With reference to STRAT 12 Northfield Local Plan 2034.

I frequently walk the footpath over to Garsington and, as a friend of the local farmer in Horspath, around the fields on the Horspath side. They are frequently boggy and flooded in part. I worry about the effect on the wildlife if building is allowed on this Green Belt site. As I walk the fields there's an abundance of wildlife to be seen, including many bats flying around, are these not protected?

We moved to Horspath from Oxford City when our children were young, we choose to live in a village and the thought that one day Horspath may become part of an urban sprawl is very upsetting.

Another very important factor of any new building around Horspath is an increase to traffic in the village, we already serve as a 'rat run' from commuters escaping the busy ring road around Oxford.

I request that Northfields is completely taken out of this local plan 2034
