I am 16 years of age and have lived in [REDACTED] all of my life. I do not agree with the development proposed at Chalgrove Airfield. I enjoy living in a rural setting as opposed to an urban area, and building on the airfield would make our surrounding area feel too built up. There is historical value to the area and this should be preserved.

I have concerns with regard to the levels of traffic should the development go ahead. Our local roads already get blocked up at peak times. Diverting our main road would result in more traffic through our village. We could end up with pollution issues just like Watlington.

I believe that Martin Baker Ltd should be allowed to continue to use the airfield without housing. What they do is extremely important. They save lives. How can it be safe to have 3000 houses so close to an active runway? A development of 3000 houses would impact on what Martin Baker could do and this shouldn't be allowed to happen.
