I do not think any village should have to sustain growth of more than 10%. As a village [REDACTED] already growing by nearly 30% with the addition of 320 new homes. This cannot be sustainable in such a rural location and is not proportionate to the existing village. Every area should help to meet our Districts unmet housing need.
