I have concerns about the potential for radioactive waste from Culham Science Centre.

I strongly feel that The Plan is not sound, positively prepared, justified or deliverable and was rushed through debate by councillors in the space of one week immediately before Christmas with key documents not made freely available. Councillors were 'whipped' to agree the Plan.
