I believe that LP2034 should be treated as a new plan rather than a modification of LP2033 and that the consultation period should have been considerably longer - months rather than weeks. I am not convinced that it being driven by an accurate assessment of housing needs. National Planning Guidelines have not been complied with (paras 16b and 30). Much of this need could be provided within the Oxford City boundaries, without encroaching on valuable Green Belt. Political undertakings about the protection of the Green Belt are not being upheld. I am particularly concerned about the effect of the Plan on wildlife and air quality in South Oxfordshire. Evidence and assessments on road development are inadequate. Detailed information about the housing proposed for Bayswater Farm has not been provided by LP2034 or otherwise
