No consultation has taken place with the local residents or Sandhill parish council.

Have flooding risk assessments been performed? Hard to see how there would not be flooding issues, given the lay of the land and existing brook.

How would traffic be dealt with? Through traffic would be an absolute nightmare for local residents, many of whom are families with young children.

As we understand it, neighbouring local authorities have not been involved in the current process and thus this section of the local plan should not be adopted.
