Policy STRAT4 paragraph 4 states that “Proposals must ensure that necessary supporting infrastructure is provided. Developers must engage with relevant infrastructure providers to ensure the implementation of the Infrastructure Delivery Plan.”

However, The National Audit Office report – Planning for New Homes¹ - 8 Feb 2019, points 16, 18 – 20 make it clear that “The way infrastructure is funded is complex, involves several government departments and private developers and lacks cohesion and certainty.”, “The system to get contributions from developers towards the cost of infrastructure is not working effectively.” “Developers can use the planning system to pay less in contributions than agreed.” and “Contributions to the cost of infrastructure and affordable housing agreed with developers are not keeping pace with increases in house prices.

Each strategic site requires a significant amount of infrastructure to be delivered to meet the needs of the residents and mitigate against the damage caused by developments. It would seem that under the current funding system, and looking at the Infrastructure Delivery Plan which shows many gaps in where funding is coming from that it is possible the these sites will not deliver the infrastructure required.

For example, it is still not clear how the traffic issues at Cuxham, resulting from the proposed Chalgrove allocation, will be resolved
