Please provide further information in relation to the previous question. e.g. why you do or do not consider the Local Plan to be legally compliant or sound.

The current wording in this policy means that major development sites may come forward outside of the Neighbourhood Planning process, as happened in Chinnor recently APP/Q3115/W/17/3187058, which is contrary to the policy for larger villages, where major development sites should only come forward through the Neighbourhood. Its current wording means that large unplanned for sites may come forward. The case in Chinnor resulted in the approval of a major development of 140 dwellings on a site of nearly four hectares as the current local plan does not limit the size of an infill site in larger villages. The Planning Inspector also stated that “it is not necessary to have 4 or even 3 sides occupied by development nor are adjacent buildings to be hard up against the boundary.”

Furthermore, many other & smaller villages are long and straggling settlements, and the wording in this policy does not limit the number of small infill sites in such settlements and this policy as it stands could mean they end up more than doubling in size.
