Policy H1 of the Final Publication version of the South Oxfordshire Local Plan 2034 (FPSOLP2034) seeks to explain the strategy for the delivery of housing. In summary, the housing delivery is expected to occur at the strategic allocations, smaller sites allocated or carried forward from adopted development plans, and sites allocated in neighbourhood development plans. It appears that the housing land supply is reliant on the delivery of strategic allocations and development coming forward through neighbourhood plans, and a limited amount of development is directed to the market towns including Wallingford.

Policy H1 also refers to a housing trajectory. Croudace Homes' representations to Table 5c comment in detail on the housing trajectory and housing delivery and are relevant to Policy H1. In summary, it is requested that a detailed housing trajectory containing information on the predicted timing and delivery of development at all of the sites that make up the housing supply is provided in FPSOLP2034. It is considered that the assumptions about the commencement of development at the strategic allocations are unrealistic, and should be amended to realistically reflect the actions that still need to be completed and national evidence on housing delivery rates.
