H6 - This policy is too negative restrictive to be effective in supporting sustainable developments in rural areas: it neglects to take into account the sustainability of groups of settlements. Some small villages are very close to larger settlements which means that journeys are short and growth can help to support facilities in nearby villages and towns. It is wrong to limit and prevent new dwellings as this effectively freezes the size of such villages and prevents natural incremental growth.

H16 - The definition of infill development is likewise far too restrictive to be effective, it is negative and results in pressure to intensify the densities of any new development. It does not to encourage large or medium sized plots within loose knit village environments, that are in keeping ion a village context and cause no harm.
