STRAT 4 Strategic Development – This policy deals with the implementation of the Spatial strategy. This is an unsound policy because it fails to be effective in delivering key objectives of the plan namely, the promotion of sustainable modes of transport (OBJ 4), the provision of affordable housing where it is most needed (OBJ 2) and the promotion and protection of sustainable locations for economic development (OBJ3) Objections are raised to this policy on the following grounds:

1. That it does not require the Strategic Allocations to demonstrate how they will provide effective public transport links to Oxford.
2. The Chalgrove allocation cannot comply with this policy because it requires "high quality public transport facilities" in the vicinity of the site, these are not deliverable at Chalgrove.
3. That it does not explicitly require the developments to demonstrate how they are dealing with affordable housing needs of Oxford, one of the key problems caused by Oxfords inability to expand.
