The development of Chalgrove airfield for 3,000 homes is the least sustainable location of all the allocations in the Local Plan. Chalgrove is poorly located to employment centres and major development will result in significant car commuting to London and surrounding towns, particularly Reading and Oxford. The proposed mitigating transport measures will only increase vehicle movements in the surrounding countryside, causing congestion in local villages and giving rise to unsustainable travel patterns. The proposed allocation does not meet the requirement of sustainable travel policies, and indeed many of the local roads are unsafe and distances too great for cycling.

Chalgrove airfield is called 'brownfield development' in the Local Plan. In fact, most of it is open countryside where, should it no longer be required for aviation purposes, could easily be returned to agriculture. Many second World War airfields were returned to agriculture from the 1950s onwards, and Chalgrove should be similarly treated.

However, in recent years the MOD has tried to maximise the economic potential of a number of unused airfields in open rural areas, resulting in unsustainable residential and commercial development. Housing England has been brought in to bulldoze this major proposal for housing, at the expense of the proper forward planning of South Oxfordshire. This should be resisted in Chalgrove.

Strat 7 is contrary to Strategic Objectives OBJ 1.2, OBJ 3.2, OBJ 3.3, OBJ 8.2.
