Climate Change Objective 8, the last objective in the Local Plan, does not seem to be as strongly worded as it could be, bearing in mind that climate change is the single most important factor which is likely to affect our lives in the plan period through to 2034. Surely, if SODC takes climate change seriously, it should be the guiding factor which determines all the objectives, policies and land allocations in the document?

Policy TRANS2 on transport matters is well intentioned and says all the right things, but this philosophy is not followed through in some of the major proposals, particularly at Chalgrove.

I can see that some of the Built Environment Policies, for example DES8 and DES9, refer to climate change issues and identify what applicants can do to mitigate the effects of changing weather patterns and promoting renewal energy. However, I do not think that these policies alone will have the desired effect of achieving the Government's target of reducing carbon levels for 2050 to be at least 80% lower than the 1990 baseline. More needs to be done to put this into effect, at both Government and Local Government levels.

The approach to climate change in the Local Plan needs to be strengthened if South Oxfordshire is to play its part in starting to resolve these issues.
