

I'm against development of Chalgrove Airfield for a variety of reasons.

1. Road infrastructure is entirely inadequate. Chalgrove is an isolated remote location. There's no rail service here and minimal bus services. It will result in busier inadequate roads and more air and pollution.
2. There's no demand within Chalgrove for the development, just a resentment that the preferred rural lifestyles are being undermined by remote planners. We already have an agreed Neighbourhood Plan for reasonable housing growth, which was adopted and supported by referendum.
3. The idea of taking up Martin-Baker's runway and replacing it with a shorter one is ridiculous. It will limit the operations of the company at enormous expense. The planned development will also put new housing in close proximity to the active runway, which must have safety implications as well as providing noise pollution to any new development. I understand there is regular explosives testing undertaken by Martin-Baker.
