Paragraphs 4.90 to 4.101 and STRAT 11 correctly identify this proposed allocation as being highly sustainable and very well integrated with Oxford city and its employment sites. Similarly paragraphs 4.102 to 4.106 and STRAT 12 note that this location is also both sustainable and close to where the unmet housing need in Oxford city arises. The two sites co-ordinate well with each other and can provide cycling and walking infrastructure which well connected to Oxford city. As a Didcot resident I have seen ever increasing congestion in our town because so many Didcot residents work in Oxford and cannot conveniently reach many of the employment sites by public transport. I have long felt that the failure to develop the land at Grenoble Road has caused many unwelcome journeys across the green belt from housing sites in South Oxfordshire. It makes more sense to build the houses near to the jobs.
