I consider that the site proposed, abutting Abingdon with its many fine schools, is totally inappropriate and provide a few comments.

1. It is in the GREEN BELT, which is supposed to provide the lungs for neighbouring towns and prevent encroachment from these towns. It is contrary to National Policy and there are no 'exceptional circumstances'.
2. It is in a loop of the river Thames with all the consequential traffic issues which can cause gridlock, especially during school terms. On one occasion, it took 45 minutes to travel one mile from Culham Science Centre to Clifton Hampden traffic lights. Traffic links are poor, and many more houses and vehicles will only exacerbate the situation, even if a new bridge were built over the river Thames.
3. Is the intention really to transform Oxfordshire from a Shire to a concrete conurbation? South Oxfordshire was considered one of the best places in the country to live. It certainly won't be if this very poorly thought-out idea goes ahead.
