Sandhills is a small estate and enjoys the peace and quiet before exiting onto a the already congested A40.

Traffic in the area has already been increased with the extension of the Park and Ride. Additionally, traffic will be added once the Nielsen building works is completed. Sandhills is small with narrow roads and can not cope with any additional traffic going through as the new road layout suggests.

The Bayswater Field is a valuable asset to the community of Sandhills and Barton. Start building in the green belt, will it then creep into the next field on route to Forest Hill?

This development will cause irreparable damage to the environment and should be removed from the plan. To build on green belt you need exceptional circumstances, this is not the case.
