Government planning policy sets out that the green belt should be protected, unless exceptional circumstances apply. However, there are no recognisably exceptional circumstances to be found in this case. Therefore, the protection of the green belt needs to take priority.

I cannot see how the proposed plans are sound in any way. This is the second time I am objecting to the plans. The changes that have been applied still do not make it sound.

The plans were rushed through a debate close to Christmas. I am suspicious that this was in part to brush over the fact that the plan does not provide 'exceptional circumstances' to justify cutting into the protected green belt.

There is no need for such a large amount of houses in the proposed location. It would only serve to add to the urbanisation of a rural community. A simple assessment of the current traffic situation at peak times, should be reason enough to scrap this plan. The whole plan is ill-thought-through and cannot be made viable even with amendments.
