Sustainability.

Chalgrove Airfield has poor sustainability - this site would create a car based community and create significantly more traffic than the strategic sites closer to Oxford.

The Chalgrove Airfield would create a lot more traffic on country lanes and require significant investment from Oxfordshire County Council which has said that it doesn't have the money available.

Delivery and Viability.
