1. I support the Plan's recognition that a flexible approach to the protection of the Green Belt is to be taken if the housing needs of Oxford are to be met in sensible proximity to the City itself.
2. The proposal that other sites located some distance from Oxford, Chalgrove is an example some 10 miles distant, would involve the destruction of exceptional countryside that is comparable to the Green Belt but for its distance from Oxford.
3. Further the impact on other rural communities would be devastating and greater than the impact on Oxford of adopting such sites as Grenoble Road.
4. The Plan's inclusion of other sites in addition to Grenoble Road, including Berinsfield, Culham, Wheatley, Bayswater Brook and Northfield support the aims at 4.40 and 4.51 of the Plan to utilise the further support the existence of the Science Vale and Didcot.
5. The Plan recognises that there are "special circumstances" in this particular situation where the alteration of the Green Belt is needed to meet the objectives.
