The allocation of the Grenoble Road site is a logical and strategically sound policy:

1. The site is on the edge of the Oxford conurbation which is from where the demand pressure for additional housing emanates.
2. The site is close to the science park and various industrial compxes and is therefore the best placed site to supply and benefit from the employment opportunities that the Plan is aiming to satisfy.
3. The site's close proximity to Oxford and local industry is a positive step in meeting Obj.2 – minimising carbon emissions.
4. The infrastructure to meet the additional housing is largely in place and functioning obviating the need for new infrastructure projects that would be necessary for other more remote sites, notably Chalgrove Airfield.
5. There is a clear and compelling case for “exceptional circumstances” to take the Grenoble Road site out of the Green Belt.

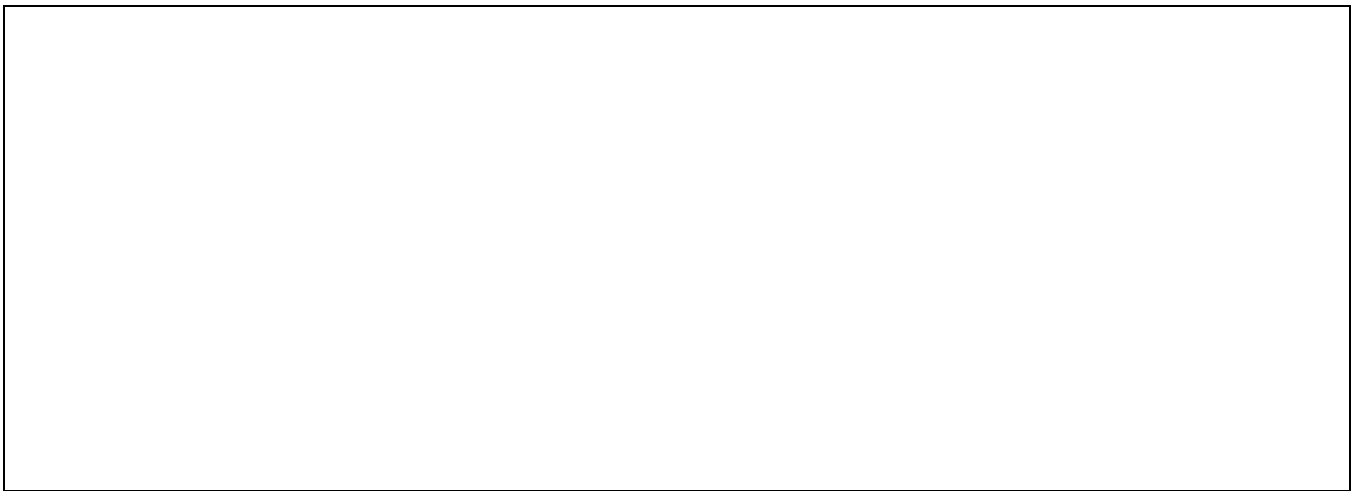
