I am against the option to develop Chalgrove Airfield.

The area is surrounded by small rural villages that would be very adversely impacted by traffic avoiding what are already congested roads. Traffic would use unsuitable the small country lanes. Recent development in Benson (perhaps only 20% completed) has already impacted traffic movement through our villages (Berrick Prior/Berrick Salome/Roke & Rokemarsh).

We recently conducted an ATC survey that demonstrated that on some days the traffic was already double the developer's prediction of 2023 traffic. We have 40-55% of vehicles speeding at over 35mph. Some vehicles were recorded between 60-70mph. These are narrow, no pavements, lanes with Horses, dog walkers, runners, cyclists. The prospect of these lanes becoming busy with rat-running traffic would be dangerous and destroy quality of living in this area.

The new Oxbridge Corridor is the ideal solution to release suitable development opportunities with good road infrastructure.
