I do not consider that the proposed development north of Bayswater Brook (SRAT 13) to be a sound plan. First, it requires the moving of Green Belt boundaries allowing the City of Oxford to sprawl into the countryside. This is not in line with STRAT 1 and STRAT 6 which are policies designed to protect the greenbelt. Second, this area is very visible from Barton and Headington. Third, it will also add to the congestion every morning as the traffic builds up quickly on the approach from Bayswater Road to the Headington roundabout. Fourth, the precious areas of Sydlings Copse and College Ponds will potentially be threatened by the close proximity of this development.
