

*Wildlife and ecology eg deer, pheasants, badgers, foxes, etc will be adversely affected and we consider that there could be pollution to Bayswater Brook as the land sloped towards it. We would be concerned for their ruination of their habitat. Landscape, wildlife, trees and plants would be affected.

*The countryside views of this part of the Oxfordshire green belt will be badly affected.

*We already have a terrible traffic congestion and pollution which is evident at the Headington roundabout especially at rush hour. This would become absolutely intolerant by excessive housing development in the area.

*There will be problems of flooding, harm to biodiversity, loss of valued farmland and landscape

*SODC has not assessed Bayswater Farm and as a result we would suggest that its not legally compliant.

Also we have not been advised of the SODC's intentions and they are trying to bypass our entitlement or prerogative to be appraised of the facts and figures.

*The Minister of Housing James Brokenshire on BBC 4 Any Questions on 11 January 2018:' on the Green Belt absolutely I think that needs to be protected, that needs to be safeguarded. Now I'm not one who is advocating that we should be effectively all over our green belt in order to hit those housing targets. I think that we can do this creatively , how we use the existing built environment and indeed that brownfield sites that are there. And actually the protections that are around the greenbelt have been upheld and strengthened through our planning guidance to ensure that is thee focus.'
