The Council considers there should be mention here in the spatial strategy for Thame of supporting development that contributes to the completion of an off road cycle network from Thame to Haddenham via Haddenham and Thame Parkway railway station. If safe network existed then the other objectives in the local plan of improved accessibility to Thame by cycling and higher residential densities where there is better access by cycle could be better achieved.
