Thame Town Council objects to modifications proposed for Policy H3.

The insertion of "minimum" and "at least" is potentially harmful. Appeals in the South Oxfordshire area has resulted in allocations within neighbourhood plans being greatly intensified as Inspectors have agreed the use of "minimum" and "at least" are welcoming of further development.

Thame Town Council notes its exemplary delivery through the existing Thame Neighbourhood Plan. The Town Council believes that the prescription of site-specific numbers and an overall limit across the sites has given certainty to both developers and the public. Early attempts by developers to raise dwelling numbers on the major allocation sites were not supported by the LPA and the result has been rapid delivery in line with the Thame Neighbourhood Plan and Core Strategy 2012, rather than months and years of interminable amendments and new schemes.

The Town Council does not recognise the need to use the terms "at least" or "minimum" in relation to any housing allocation for the market towns and seek their removal as an amendment to the modification. The market towns have delivered far above their Core Strategy requirement. Thame is likely to again provide reserve sites in the revised Thame Neighbourhood Plan as one of those from the existing plan has recently been triggered in Thame, in line with NDP policy. In providing certainty in terms of numbers, and a cap exclusive of windfall etc. for its main allocation sites, it is suggested that Thame, and the other market towns, will have greater confidence in actively increasing our allocations to provide for very local needs.

â€The Town Council accepts the need for specialist housing for the elderly in Thame and that the provision be made in addition to that proposed in Table 5d for the reason outlined below. However, given that we are aware that the private sector is seeking only the most lucrative formats, the Town Council suggests an addition to the proposed modification H3 2. : "This will be delivered through a review of the Neighbourhood Development Plan". Thame is seen as affluent but it is only relatively so; many of Thame's older residents rely on state or private pensions gained from working in traditional, older industries and do not have the income now associated with the area. Oxfordshire County Council has stated against planning applications that it will be difficult to recruit sufficient numbers of care workers in Thame, given the relative low-incomes associated with such work and our high housing costs. This strongly suggests that Thame may not be able to host more than a very few care homes; it is therefore essential that we have positive control of specialist housing in order to avoid providing only high-end retirement and care living.
